Pursuant to Law No. 6698 on the Protection of Personal Data ("Law"), we would like to inform you about the processing of your personal data within the scope of your requests regarding your rights by MEİS CHARGE TEKNOLOJİLERİ A.Ş. (MEİS CHARGE) acting in the capacity of data controller.

Within the scope of your applications regarding your rights, your personal data will be processed in order to make evaluations regarding your application that you have submitted within the scope of exercising your rights, to finalize your application in accordance with the legislation, to carry out the necessary transactions within this framework and to store your personal data in accordance with the legislation.

In line with the realization of the relevant purposes; your personal data processed based on the legal reasons for the establishment, exercise and protection of a right and the fulfillment of our legal obligations, (i) limited to the notification to be made in case you request the correction and destruction of your personal data to be notified to third parties, notifying the relevant parties to whom personal data is transferred (ii) if required by the legislation, it may be transferred to authorized public institutions and legally authorized private persons.

As a data subject, you have the following rights under Article 11 of the Law:

- Learn whether your personal data is being processed,
 - Requesting information in case your personal data is processed,
 - To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
 - To know the third parties to whom personal data are transferred domestically or abroad,
 - To request correction of your personal data in case of incomplete or incorrect processing,
 - To request the deletion or destruction of your personal data within the framework of the conditions stipulated in the Law,
 - It has been confirmed that your incomplete or incorrectly processed personal data has been corrected by the third party to whom the personal data has been transferred.
- to be notified to persons,
- To request notification of the deletion or destruction of your personal data to third parties to whom personal data is transferred,
 - By analyzing your processed data exclusively through automated systems, you may not be able to create a negative impression against you.
- don't object to the outcome,
- In case you suffer damage due to unlawful processing of your personal data demanding redress.
